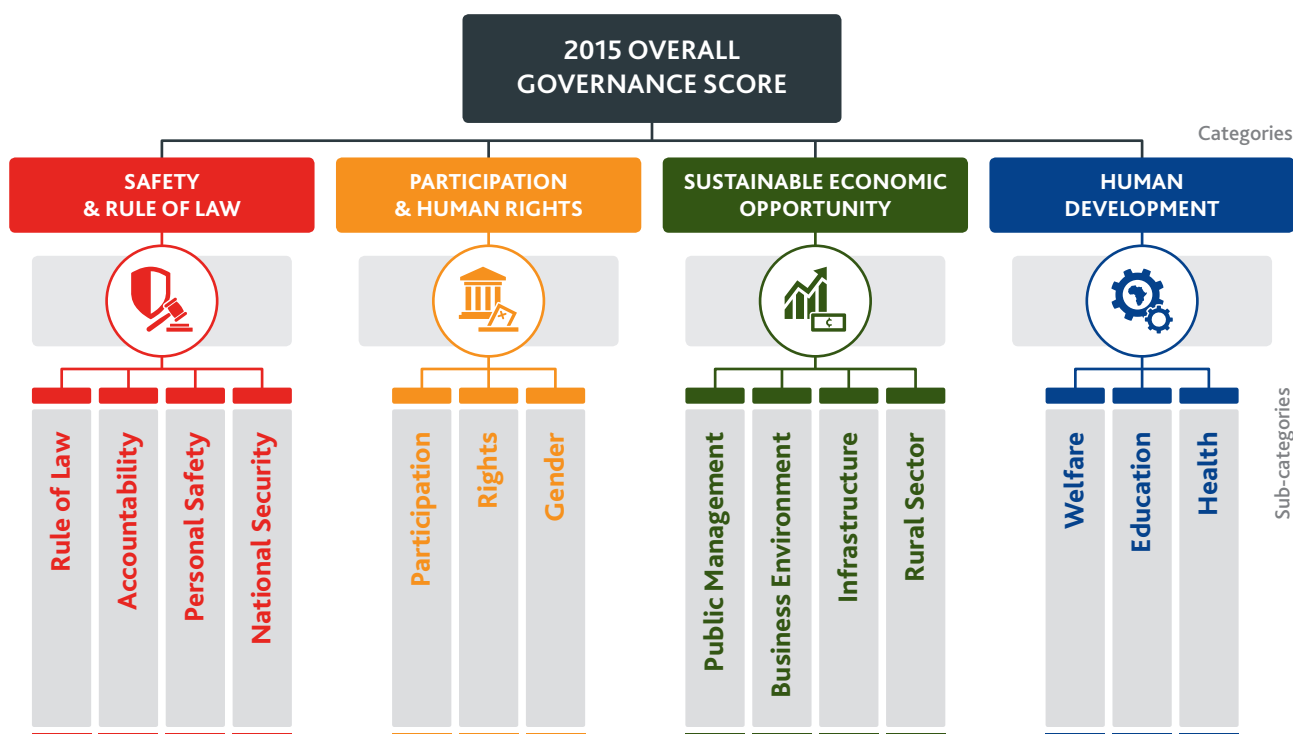

All figures have been rounded to the nearest one decimal place. This means that countries may appear to have the same score, or the change over time may appear inaccurate, but this is not the case when all decimal places are taken into account. Countries have been ranked and trends have been described on the basis of full scores not the rounded numbers that appear here.

Regional Economic Community (REC) averages are calculated by applying the REC's current membership configuration for all data years.

The Mo Ibrahim Foundation (MIF) is aware that some sources update their data sets after our documentation is sent to print. IIAG raw data are correct as per the date 'last accessed', which is stated for each indicator within the Data Portal (www.moibrahimfoundation.org/iiag/downloads/).

South Sudan and Sudan are excluded from all group averages pre-2011 as neither country existed in their current configurations before the secession of South Sudan in 2011.



The Ibrahim Index of African Governance (IIAG) measures the quality of governance in every African country on an annual basis. It does this by compiling data from diverse global sources to build an accurate and detailed picture of governance performance in African countries.

The broad aim of the IIAG is to better inform and sustain the debate on African governance by providing a transparent and user-friendly resource to:

- support citizens, governments, institutions and the private sector to accurately assess the delivery of public goods and services, and policy outcomes.

- encourage data-driven narratives on governance issues.
- help determine, debate and strengthen government performance.

The IIAG was created in 2007 in recognition of the need for a quantifiable tool to accurately measure and monitor African governance performance, its progress over time and across countries, and as a means of supporting effective and responsive solutions to complex public policy challenges in developing countries. Policies need to be evaluated by their results, which can only be done if accompanied by robust data.

Gambia is one of five countries to have shown deterioration in every category in the past four years. This trend is reinforced at the sub-category level, with Gambia registering only minimal progress in *Rights*, *Business Environment* and *Education*.

In *Safety & Rule of Law*, the category in which it shows its most pronounced decline, Gambia shows improvement in only one indicator.

Gambia's broad-based downturn in governance performance, even in *Human Development* in which it receives its highest rank, is a particular cause for concern.

Overall governance: considerable decline fuelled by worsening performance in all categories.

Gambia scores 50.5 (out of 100) in overall governance, ranking 27th (out of 54) in Africa.

Gambia shows overall governance deterioration (-1.7) since 2011.

Gambia scores higher than the African average and lower than the regional average for West Africa.

Gambia is ranked 8th in West Africa in overall governance.

***Safety & Rule of Law*: concerning deterioration across all sub-categories.**

Gambia scores 50.1 in *Safety & Rule of Law*, ranking 33rd on the continent.

Within the *Safety & Rule of Law* category, Gambia's best sub-category performance is in *National Security*, scoring 83.6.

Gambia's weakest sub-category performance in the *Safety & Rule of Law* category is in *Accountability*, scoring 29.8.

Gambia has shown a deterioration (-3.9) in *Safety & Rule of Law* since 2011. This has been driven by deterioration in all four sub-categories: *Rule of Law* (-2.2), *Accountability* (-3.9), *Personal Safety* (-8.8) and *National Security* (-0.6).

***Participation & Human Rights*: negative trend in *Gender* halts progress.**

Gambia scores 36.4 in *Participation & Human Rights*, ranking 43rd on the continent.

Within the *Participation & Human Rights* category, Gambia's best sub-category performance is in *Gender*, scoring 55.8.

Gambia's weakest sub-category performance in the *Participation & Human Rights* category is in *Participation*, scoring 24.8.

Gambia has shown a deterioration (-1.5) in *Participation & Human Rights* since 2011. This has been driven by deterioration in one of the three sub-categories: *Gender* (-6.9).

Sustainable Economic Opportunity: improvement in *Business Environment* balanced by marked decline in *Infrastructure*.

Gambia scores 50.2 in *Sustainable Economic Opportunity*, ranking 17th on the continent.

Within the *Sustainable Economic Opportunity* category, Gambia's best sub-category performance is in *Rural Sector*, scoring 60.6.

Gambia's weakest sub-category performance in the *Sustainable Economic Opportunity* category is in *Infrastructure*, scoring 43.5.

Gambia has shown a deterioration (-0.9) in *Sustainable Economic Opportunity* since 2011. This has been driven by deterioration in three of the four sub-categories: *Public Management* (-0.7), *Infrastructure* (-4.1) and *Rural Sector* (-0.8).

Human Development: deterioration in Gambia's highest scoring category.

Gambia scores 65.3 in *Human Development*, ranking 13th on the continent.

Within the *Human Development* category, Gambia's best sub-category performance is in *Health*, scoring 78.0.

Gambia's weakest sub-category performance in the *Human Development* category is in *Welfare*, scoring 58.7.

Gambia has shown a deterioration (-0.7) in *Human Development* since 2011. This has been driven by deterioration in two of the three sub-categories: *Welfare* (-1.2) and *Health* (-1.2).

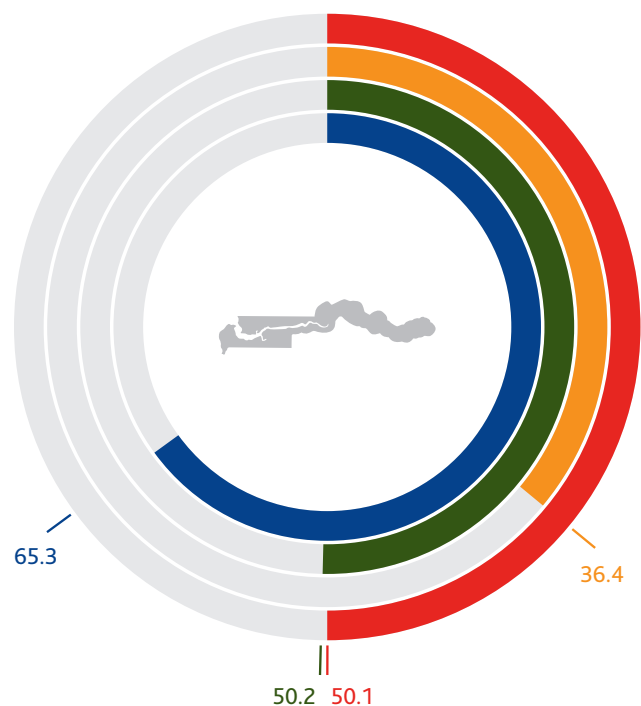
